Welcome to the land and soil jurisdiction of Self-Governance, where We the People proclaim and preserve, represent and revive our Nation's greatest virtues and uphold the sanctity of the divine design of our Creator and laws of this country. To be a People means to be self-governing and champion these Truths for the sake of our freedom, our abundance, and for all others enslaved to tyranny. This is an awesome responsibility and one worth protecting and practicing.

Unfortunately, through miseducation and the misuse of power, people have fallen under duress and, in their suffering, people become complacent. They have been deceived about many facts and facets of law and authority, including their inalienable rights and duty to this country and each other. They have been led astray and tricked into believing they are receiving bread when it is a stone, fortune when it is slavery, and life everlasting when it is a death sentence. Thankfully, through their courage and faith, our forefathers left us an antidote. The wisdom and power to prevail comes from our birthright, our Bill of Rights, The Constitution, common law and common sense. We the People will stand upon this foundation to free ourselves once again. We all have been duped. To be sure we don't suffer the same fate as before we must be courageous warriors: diligent and humble, as fierce as we are benevolent. When we are the thriving beings our Creator has intended, we will rise out of indignation and into empathy, accountability, and purity.

In this manual, you will be reorienting yourself with the basic building blocks of what it is to be a State National, how to do it, and why it is important. A glossary can be found at the end of this manual to provide clarification of the terms. A directory of resources will help you find answers to questions and give recommendations on where to go next. You will be required to be self-governed, encouraged to grow, and be responsible for your conduct. Re-education, self-discipline, and unlearning is of the utmost importance because it is where our empowerment begins and tyranny ends.

# Jurisdictions JURISDICTIONS

#### Land & Soil - Sea (Maritime) - Air

There are three basic jurisdictions possible — air, land, and sea, and three basic capacities, unincorporated, corporate, and incorporated, in which we may function, so a total of nine (9) different basic combinations. It is of paramount importance for everyone involved in the State Jural Assemblies to understand the basics of jurisdiction. A jurisdiction is "invoked" or "claimed" as a result of the (1) subject matter and (2) capacity of the parties involved in a dispute.

#### Land and Soil Jurisdiction or Common Law (unincorporated)

Land and soil jurisdiction is populated and operated by living, breathing people, known as Lawful Persons. The Land is divided into public and private law or as they are more popularly known, common and statutory law.

State Nationals and State Citizens are operating on the "land and soil" of their State, addressing the issues that impact the living American people and their assets. They are invoking and enforcing the Public Law, including the Constitutions.

#### **Sea or Maritime Jurisdiction (incorporated)**

The Sea Jurisdiction (British Monarch/Britannic Majesty) is divided into maritime (aka "civil law" or

"commercial law") and admiralty (martial law). Maritime law is also defined as Civil or commercial law and Admiralty (martial law).

"They" the "U.S. Citizens" are operating in the foreign international jurisdiction of the sea as part of an incorporated Territorial State of State franchise or in the foreign global jurisdiction of the air as an incorporated Municipal STATE OF STATE franchise. They are addressing the affairs and assets of legal fiction "Persons". They are enforcing the private law of their corporations on their employees and shareholders and franchises

#### Air Jurisdiction (corporate)

The Air Jurisdiction is based on Canon Law of the Roman Catholic Church and divided into two subsections ecclesiastical (Pope) and municipal law (Pontiff). Jurisdiction of the Air is limited to Municipal Jurisdiction, which was confined to the ten miles square of the District of Columbia — and never intended to usurp beyond the Municipality of Washington, DC — though it has. Incorporated states and Municipalities are in this category.

The only interface of the Soil/Land Jurisdiction and the Sea/Air Jurisdiction is located in international jurisdiction where Lawful Persons populate the land and Legal Persons inhabit the sea, and they may be converted either unlawfully or lawfully, one into the other.

What we are doing by reclaiming our birthright political status as American State Nationals and American State Citizens and by expatriating from all presumed Territorial and Municipal citizenship(s) is to lawfully convert Legal Persons back into Lawful Persons.

# **Living Soul**

### **Born Free, not Property**

To be a Living Soul on this Land Jurisdiction requires you to know a few things about your current status. When we are given a number by the Social Security Administration, it is known as a **dead entity** number or even a slave number: a title or a specification number that allows the government to employ you as their asset. They use it to enslave you and to ensure their interest, to make money in offshore accounts, and conduct trusts under your name.

Your name, whether it is John Hamilton Doe, John H. Doe, or JOHN HAMILTON DOE, are incorporated fraudulent entities enlisting you as their property and through guileful words and documents you continue to file under the sea jurisdiction or "US Citizen", as explained before. This name makes you a "person," not a "people." You have privileges, not rights. You operate in a legal – not lawful – jurisdiction.

This name merely objectifies you as property, forced to abide by the corporate constitutions as contract slaves and to act in obedience to their benefit. This is not intended for your protection and freedom of rights. The only US Citizens are Federal employees and foreign entities here on business.

# Recording, Publishing, and Reclaiming your Status

#### This is how you become documented as an American State National or State Citizen

There are two ways of submitting documents to change your status from a US Citizen to a Living Man/Woman.

**The 1779 "short" ONE PAGE** document — along with two Witness Testimonies — limits participation in the Arizona Assembly. You will solidify your status as State National and regain all your rights including voting privileges within the County and State, jury duty, and ability to sit on some committees. Many who choose this path are considered retired and choose not to be involved in building the true government.

**1779 Document**: Also known as the ONE PAGER, The Declaration of Naturalization is a one page document used to correct your status, a statement of Notice that you are no longer lost at sea and have returned to the land and soil and have reclaimed your name, body, and soul. You are no longer for hire or under the de facto control. **There are five specific 1779 Declarations**:

- 1. For individuals born on American soil.
- 2. Immigrants that have been naturalized as Americans.
- 3. Immigrants with green cards or other documents.
- 4. Immigrants residing in America seven years or more.
- 5. Military or federal employees as well as Americans collecting Government assistance.

The 928 Documents or 928 Bundle are a series of eight documents that are covered below. The documents are known to be irrefutable and show a deeper desire to be involved in the building of the true and only government. By recording and publishing your 928's, you are setting yourself up to be a part of the governing body of the Republic. You will be able to hold an office, if qualified, claim the status of a State Citizen, vote internationally, and sit on any committee you choose.

- 1. **Deed of Re-conveyance**: For American-born citizens, this seizes all other claims of your "trade" name and brings your name back to the land and soil as yours and not for trade.
- 2. **Deed of Conveyance**: For those born outside of American land and soil, but seizes all claims to your "trade name" and brings it to the land and soil jurisdiction as yours and not for trade.
- 3. **Certificate of Assumed Name**: Seizes the ability of the de-facto to use any of the variations of your trade names and gives them back to you (for example, Jane Doe, Doe Jane, Janie D, JD, and so on).
- 4. **Cancellation of All Prior Powers of Attorney**: Your previous signatures authorized MANY powers of attorney without your knowledge or consent. This gave corporations power and control over you. Canceling these powers returns the control back to you and out of the hands of the corporations.
- 5. **Act of Expatriation I, II, & III**: Your corporatized name has been given different variations of use: JOHN DOE, JOHN MARK DOE, JOHN M. DOE. These papers re-record each variation and reclaim each name as yours.
- 6. **Mandatory Notice (FSIA)**: This is a notice to all legal and lawful entities, territories, States, counties and so on, declaring claim to and ownership of your name.
- 7. **Paramount Claim of Life**: Claims your DNA from the moment of conception under your copyright to protect it from being used by the de facto, corporate industrial complex. This includes ownership of your placenta when you were born, blood drawn at the doctors, etc. With this form, they may not use your DNA.

#### In addition to the above, you will also need the following documents:

- **Birth Certificate**: Original or Copy (this does not get published, but stays in your State File)
- **Witness Testimonies**: Anyone can be your witness that is 18 years of age, has known you for seven years or more, is of sound mind, and can verify you are who you say you are. You will need 2 witnesses.
- **Naturalization Papers**: Original paperwork or certificate that shows you have been Naturalized as a US CITIZEN.
- **Two Passport-Type Pictures (in color)**: Can be taken by you in your home. Must be clear, wearing no glasses, in a well lit environment, and taken against a white background. Picture should be a headshot with some shoulders.
- **Red Right Thumb Print**; Best to use ink or inkless pads for this process. If you need a digital copy, use photo paper for a clean and white background.

#### Additional recommended documents:

- 1. Baby Claim Deed (for each minor child)
- 2. Voter Registration Cancellation rescinds your voter registration by sending a letter using Registered Mail to your County Election officials. In some counties, you can unregister online instead. As an American State National. you will no longer vote in the de facto corporation "elections." You must provide confirmation that you have been removed from voter registration. This will be sent to your County Chair to be kept in your file. You will keep a copy for your records Your State Recording Secretary can provide this letter for your convenience.
- 3. Revocation of Election to Pay Income Tax letter (can be sent by any man or woman.) This is a simple one page letter. Your State Recording Secretary can provide this letter for your convenience.
- 4. Military Severance Letter is mandatory for all veterans (gets published before your documents)

Contact the State Coordinator or a Recording Secretary in your County to begin this process at thearizonaassembly.org. They are trained and are here to help you succeed in changing your status lawfully.

#### NOTES:

All letters should be sent **Registered Mail**, with return receipt requested, using green card form #3811.

All documents are provided free of charge by the State of Arizona. Documents can be notarized by a Notary Public or by an Assembly Recording Secretary, please let the Recording Secretary know so you have the correct Notary Block on your paperwork.

You will make 3 copies of ALL documents and have ALL 3 documents notarized:

One Pager and 2 witness statements: 9 originals (nine pages)

928 Docs and 2 witness statements: 36 originals (approx..39 pages)

#### Volunteer

You are now an American and have a duty to yourself and to America to help restore our country to its rightful place in the world of nations. There are many positions in the County and State Assemblies that need filling. This is what makes up our government. People like you and I that step up and populate our government positions. What are your skills and what interests do you have that could be helpful? Are you willing to get educated and perhaps trained? There are lots of opportunities for that.

#### Militia

We are all part of the State Militia and you need to understand what that means. Unfortunately, the term "militia" often has a bad connotation, but that is simply a matter of ignorance. Our militia is a community-minded peaceful group that is first and foremost concerned about the safety of our People. This may entail physical protection; organizing and helping during natural disasters like hurricanes, tornadoes, flooding; or by providing communications, first-aid, and housing, when necessary. According to Anna von Reitz, all able-bodied members of the Assembly between the ages of 21 and 65 are expected to actively support their militia in one way or another, either as active militia or acting in support, supply, communications, and administrative positions.

# Get educated and know who you are!

Although this can seem like an overwhelming endeavor, there are lots of opportunities and many resources to help you understand what our government is all about and the true history of our country, but you have to take the time and effort to learn and understand. We have all been so brainwashed, lied to, and taken advantage of by our de facto corporate government "acting on our behalf" that it is a real shocker to discover the truth.

But it is necessary to know who you are and how best to function as a State National (or State Citizen), and how to interact with the de facto. The de facto corporation government isn't going to willingly step aside and let us simply restore our original American Republic. They will obfuscate and set up roadblocks every step of the way as they have for the last 160-plus years. You need to understand that and prepare for that through education and involvement with your State Assembly.

# A Little Bit of History

## De facto vs De jure

#### De facto

The de facto is a government overturning the institution of the rightful government by setting up its own government in lieu thereof and maintaining its position by imposing its will over the will of lawful government. This includes federal and legal entities, corporations and incorporated persons, districts and territories, franchises, commerce, and anything that claims to be — but is certainly not — of The Republic or the Land Jurisdiction (i.e., the municipal courts, police departments, taxation (IRS), democratic socialism, the Federal Reserve).

# De jure

De jure government is just a true and rightful government of self-governance, established according to the Constitution, deemed lawfully entitled to the recognition and administration of its Nation or State.

Contrary to the de facto, it is a condition in which there has been total compliance with all requirements of law; of right, legitimate, lawful, by right and just title. (Black's Law Dictionary) Unfortunately, over the past 150+ years, our de jure government has been hijacked by the de facto and we have been made subject to it. This explains the "double speak" between what's lawful and legal; persons and peoples; right or privilege. This has been a temporary setback. All is changing with each living soul stepping back onto the land and soil; by participating in their State and County Assemblies, we take back our lawful government and rebuild our Nation.

# Lawful vs Legal & Public vs Private

**Lawful:** Organic law, rightful and just - the true and common law - de jure; public, people; or citizens abiding by the true law while operating on Land Jurisdiction.

**Legal:** Provided or Permitted by Law - de facto; private, statutes, regulations, registrations, corporate courts, jural societies; Persons and sea jurisdiction.

**Public:** Having to do with a nation, state or community; extending to a whole people.

**Private:** Indicates what belongs to an individual, group or company.

These terms are important when determining whether you are "part of a whole" and a people property "belonging to" someone or something. It is necessary to note that your property (home, car, or other belongings) is private to you and protected from search or seizure. In addition, you are not property, obliged to consent, and are also protected from search and seizure.

# **Bar Attorneys vs Lawyers**

Attorney, Associations/associates, Esquires, and so on are all legal terms of the de facto or fraudulent

system. It is the language of those "lost at Sea". The BAR stands for British Accreditation Registry. When they take the BAR exam, they are contracting with the British Monarchy. It is illegal and unlawful for them to operate in our court system.

Lawyers are of the de jure or Living Law Firm and are unincorporated entities. They operate with lawful intent and just conduct. They are of the **Land Jurisdiction** and protect constitutional rights.

#### States vs States of States and STATES

- A State (i.e., Ohio State) is de jure and lawful.
- A State of State (i.e., State of Ohio) is de facto.
- A STATE or STATE OF STATE (i.e., anything in all caps, like OHIO or STATE OF OHIO) is de facto, a corporation, enfranchisement, public agency, and so on.

#### Law Enforcement

In truth, the Assemblies are the "enforcers of lawfulness." It is up to us to make sure each facet of the law (i.e., Justices, Sheriffs, and so on) are honoring the law and protecting the Rights of People.

What we currently experience from the so-called law enforcement of the corporatized or de facto government is that if you get caught doing something "wrong", you will be punished, shamed, fined, have loss of privileges, and more.

In general, when we see a police officer we feel fear. There are plenty of criminals out there (our government included) and they need to be dealt with in an appropriate manner and held accountable for their crimes.

- **De facto**: Incorporated cities have police departments. They work for the Corporate United States and are legal/unlawful entities.
- **De jure**: Unincorporated cities or towns have a Sheriff's Department and are considered Lawful entities.


#### Signature vs Autograph


A **signature** is de facto and indicates your consent or signing over/contract.

An **autograph** is of the de jure; unique to you and is yours alone, as in a thumbprint, it indicates your sovereignty and ownership of your name and soul. Whenever your "signature" is required for a document, sign in blue and then autograph with a red thumbprint. If it's not a document of record and you simply need to "sign" for something, be sure to write "By:" before your name and the copyright symbol at the end. This indicates that you are the author and owner of your name, and it cannot be used by anyone other than you.

# Your American Flags







Title IV War Flag
(Also known as "the Stars and Stripes")

The second Secretary of the Treasury, a man named Oliver Wolcott, designed our peacetime flag in 1799. It had flown over Federal Courts, Post Offices, Customs Houses, Treasury Buildings, and similar installations for a total of 22 years since then. Unfortunately, it was eventually replaced with the Title IV War Flag by our Britishaligned Territorial Subcontractors that have kept themselves in a constant state of war "in our names" while exercising our Delegated Powers to do so.

This is ironic, because our actual government of, for, and by the People of this country has been at peace since 1814, and we should have been flying the peace flag this whole while — regardless of what the Territorial Subcontractors have been up to.

As beautiful and meaningful as the Old Glory War Flag is, it is also steeped in blood and misery, deprivation, loss, and shattered dreams.

The Peace Flag tells a completely different story — a happy story.

The civil government of The United States of America was restored by James Clinton Belcher, Head of State of The United States of America (unincorporated) in October, 2017, and raised the American Peace Flag for the first time since before the Civil War.

#### **PEACE Has Been Declared in America**

Immediately preceding the "civil war," delegates from the southern states walked out of Congress in protest and essentially shut down our civilian government for lack of a quorum. Lincoln subsequently declared war on the southern states and issued Executive Order 100 known as the Lieber Code, which essentially sets up a military takeover by the Union Army. Since then, we have been in perpetual war orchestrated by a British and Papal takeover of our incorporated government. Our true unincorporated civilian government has been "absent" for the last 160 years.

However, all over this country, sons and daughters of America have awakened and remembered who they are. They have declared their birthright political standing as Americans, made public record of their standing, and gathered together to bring their State Assemblies back into Session. By roll call vote, these State Assemblies have adopted a formal Peace Treaty ending The American Civil War and they have abolished slavery once and for all, in all jurisdictions. # The United States of America (Major), the United States of America (Minor), and The Constitutions

"The United States" and "The United States of America" both have "The" as their definite article, with a capital "T". This is important as an indicator of either corporate government, federal government, or an unincorporated Republican form of government.

There are two principal unincorporated entities that hold sovereign power. "The United States" holds all sovereign powers related to the soil (National) jurisdiction owed to the combined States and People. "The United States of America" holds all sovereign powers related to the international jurisdictions of the land and sea.

The United States of America is now composed of fifty (50) States of the Union and otherwise known as <u>The</u> **United States of America** (Major), and there is <u>the</u> **United States of America** (Minor) composed of the Seven Insular States more commonly thought of as federal territories and possessions of Guam, Puerto Rico, the State of New Columbia (that is, DC), American Samoa, et al.

The United States of America (Major) is populated by **American State Citizens** whereas the United States of America (Minor) is populated by **US citizens**. American State Citizens have natural and unalienable rights. US citizens have only the "civil rights" that the US CONGRESS (incorporated) feels like granting them.

- 1. **The Original** "The Constitution for the united States of America" is the law/contract the Federal Government must operate under with respect to the People and the Land Jurisdiction. This is the actual Constitution and only lawful contract. We are owed all our Natural Rights and a Republican form of government.
- 2. **The Corporate** "the Constitution of the United states of America" created by the Federal United States covers Articles of Incorporation of "policy" and "private law" and affecting only officers and employees of the United States of America, Inc., US "citizens," and the Territorial jurisdiction.
- 3. **The Municipal**: "the Constitution of the United States" is just another contract from and for another corporation, an offshoot of the Federal United States run as an oligarchy by members of Congress in the Washington, DC municipality, an independent city-state and not of the Land and Soil.

This is yet another glance into the duplicity of the de facto system and federal "government." Through sleight of hand, smoke and mirror, and split-tongue trickery, they have you believing if it looks like a duck, it must be a duck. Another term for this deliberate deception is "informed consent." You see, by hiding in plain sight, they can maintain that you have been informed (through symbols or similar-sounding verbiage) and therefore gave consent to their jurisdiction and rules thereof. You unknowingly become lost at sea. All Constitutions are not created equal. Every name has different implications and each flag has its own unique function. It is imperative you continue learning and absolutely necessary that you keep observing for somewhere there is a wolf in sheep's clothing.

# The Magna Carta, the Declaration of Independence, and the Bill of Rights

#### Magna Carta

The Magna Carta is a list of rights and principles stating that the King or Queen cannot demand taxes without consent from his/her legislature or parliament and that no freeman can be deprived of liberty or property except through trial or other legal process.

These rights and privileges were signed by King John of England in 1215, under the threat of Civil War from England's noblemen. It applied also to the American settlers, since they were under England's bank and rule.

However, years later, King George III had his own interest in mind and decided to alleviate his own debt from wars with France by taxing the Americans, extending his rule of compliance and deceit, and instigating conflict between the Natives and Colonists; with that, the charter of the Magna Carta was broken. Under duress, the Colonists felt the immediate and necessary need to establish independence. Putting their lives on the line, they wrote the Declaration of Independence.

#### **Declaration of Independence**

The Declaration of Independence is a record of grievances and charges directed at King George III and a formal announcement that the American colonists were breaking ties with Britain and its tyrannical control. During this time, King George III implemented his control using what we now know as *The Seven Pillars of Tyranny*.

These seven pillars are:

- 1. **Rulers:** "The king giveth, and the king taketh."
- 2. **Castes/Classes:** Reward and punishment system, the haves and have nots, us vs them.
- 3. **Things in Common:** Takeover of the economy, broken promises, and impoverishment.
- 4. **Regulation:** Control of production and distribution, needs and resources.
- 5. **Force:** No choice; compliance, demands and mandates by force or fear.
- 6. **Information:** Control of knowledge, facts and belief, what is bad is good and what was good is now bad, control of all informational sources.
- 7. **No Rights:** Privileges to be taken away, violation of rights to anyone who stands in their way.

You can see these pillars throughout history and even today. They are designed to take power from you, not give it, which leads us to... The Bill of Rights.

#### **Fundamentals of Freedom**

The Bill of Rights gives us eight principles known as the Fundamentals of Freedom.

- 1. **Self-Evident Truths:** Sound government based on clear, indisputable truths, without question.
- 2. **Laws are of God and Nature:** Laws all people must obey; laws exist from God or nature, and all men and women are equally connected to them.
- 3. **All are Equal:** Individuals and circumstances are unique, but all men and women are equal in their rights before the arm of justice and in the sight of God.
- 4. **Rights are Unalienable:** Rights are universal, from God, and cannot be taken away.
- 5. **Life, Liberty and Property:** Amongst the most important is the right to life, liberty, and to acquire, develop, and sell private property.
- 6. **Governments Must Protect Rights:** The basic reason to self-organize and set up governments is to protect those rights.
- 7. **Governments are Permitted to Exist:** The right of the People to decide how they are governed and by whom. Governments have no rights except that which is granted by the People.
- 8. **People May Change Government at Will:** People have the right and duty to change government that doesn't protect their rights.

# **Glossary of Terms**

**Admiralty:** The royal Navy of sea jurisdiction; Maritime law; a form of piracy; captain is law, civil law

**American National:** Born in the States on American soil; of birth rights and sovereignty

**Attorn:** To make or acknowledge a transfer of tenancy (possession of property)

**Attorney:** To attorn the dead on behalf of the King/Queen

Articles of Treaty: Bound by agreement

**Barrister:** Works as a Judge for the King or Queen; privileged to use his own discretion

**Citizen:** Takes up the freedom and the responsibilities of his/her duties

**Civil Flag:** Peacetime flag, symbol of civilian authority and land jurisdiction

**Civil Law:** A form of law that is opposite to common law; judge has final say without jury, guilty until proven innocent

**Civilian:** "Civil" can refer to any function of government that is not military, but "civilian" can only refer to the people as in "civilian population" – themselves

Consent: Acceptance or permission

**Constitution:** A contract; limits the power and overreach of government, foreign commerce and corporations; provides absolute power for the people and protection from tyranny

**Common Law:** Law of the land, conduct to "do no harm", no crime unless there is a victim

**Covet:** Strong desire for the possession or ownership of an object or being (entity)

**De facto:** Fraudulent form of government; criminal and untrue

**De jure:** Living, lawful government; rightful, just, and true

**Democracy:** A Greek (Helles) institution of Mob Rule, or another word for communism; represents territorial corporations, corporate officials, and corporate employees

Dead entity: A being that no longer exists

**Duress:** Forced or threatened to do something against one's will

**Enclaves:** A portion of territory or territorial by jurisdiction; of distinct characteristic

**Entity:** Being of existing matter; spirit, object or flesh

**Firmament:** The dome shaped sky; separates the waters above from the waters below

**Federal:** A government, corporation, and subcontractor

Federation: Holds the "mutual" combined "powers" of the States in international and global jurisdiction; defending in the international and global jurisdictions is the main duty of the Federation; we are a federation of States; The united States of America

**Fraudulent:** Criminally deceptive, duplicitous, dishonest, unjustifiable claims; swindle, sin

**Government:** An alliance agency for the People by the People; our employees

**International:** Entities of two or more nations, The United States, and of Foreign Nations

**Jurisdiction:** Dominion of power or authority over

Land: The earth under the first 6 inches of soil

Law: Contracts of conduct between Land, Air, and Water Jurisdictions

Land: Common Law; Rights and People

Air: Cannon Law; Roman Catholic Church;

personal property

Water (Sea): Civil, federal, and Maritime Law; the Queen; commerce and corporations

**Lawful:** The right, true, and just law of the Land Jurisdiction

**Legal:** Undoing God's law; regulations and foreign law

**Legislature:** Means of making and changing laws; made up of Lawful Persons

**Living soul:** Of mind, heart, body, spirit, and soul, born free on the land and soil; born with rights; non-dead; land jurisdiction

Magna Carta: A Charter of liberties and constitutional practices; obtained from King John of England in 1215

Maritime: Commercial or military activity at sea

**Natural Law:** What relates to everyone or erects in relation to everyone

**People:** Free, living souls on the land and soil; de jure; lawful citizens; not property

**Persons:** Of limited freedoms, dual citizenship; employed by the federal government; commerce, corporation etc.; considered property

Policy: Illegal and of limited proposal

Private: Objects belonging to men or women

Privileges: Benefits or allowances that can be

doled out or taken away **Public:** For all and from all **Record:** Account for; evident

Registry/Registration: Lists of merchants

**Republican:** With a "republican form of government", everyone in this country has both

rights and responsibilities

**Rights:** Born with; freedom to pursue life and prosperity and to not infringe on others

Soil: The first 6 inches of dirt under your feet Sovereign: From the Creator; of supreme

law; free from slavery

**States Citizen:** Lawful citizen; works on behalf of the Assembly; County, State, or Federation

**Territorial and Territorial Citizen:** Temporarily inhabited land; not populated; under military dependence; "residing" but not "populating or living on"; providing essential government services

THE UNITED STATES CITIZEN: Debt slave

Tories: Working for the British

**Tyranny:** Cruel and oppressive government; i.e., fascism, communism, totalitarianism, social democracy

Unalienable: From God and everlasting

**US Citizen:** Of the sea jurisdiction; an employee of the government and the People

War Flag: Military flag; symbol of wartime and territorial jurisdiction. (A gold fringe around a military flag means "Flag Captured"; now under martial/maritime/admiralty law and the sea jurisdiction)
